- 4. NERC and RFC 2021 Budget Mr. Sharp presented the 2021 budgets for NERC and RFC and the resulting assessments to the PJM membership.
- 5. PJM 2021 Budget Mr. Snow presented PJM's proposed 2021 budget for operating expenses and capital expenditures.
