Proposed Package	Voting Order	
Default VOM Package	Main Motion; 80% MIC Endorsement	
PJM Package	1 st Alternate Motion;75% MIC Endorsement	
IMM Package	2 nd Alternate Motion; 11% MIC Endorsement, motioned and seconded at April MRC to be voted if the Main and 1 st Alternate fail	
RECO Package	3 rd Alternate Motion; Brought forth and motioned and seconded at the June MRC to be voted if the Main, 1 st Alternate, and 2 nd Alternate packages fail
