E. Removed for separate consideration

Greg Poulos discussed the proposed Manual 34: PJM Stakeholder Process revisions addressing the motions and amendments which were posted as Consent Agenda item B. Following discussion, the proposed revisions were **approved** in a sector-weighted vote with 3.81 in favor.

Paul Sotkiewicz, discussed the proposed Tariff revisions addressing the Capital Recovery Factor (CRF) for Avoidable Project Investment Cost Determinations which were posted as Consent Agenda item B. He offered a proposed friendly amendment to add the following highlighted paragraph in Tariff Attachment DD section 6.8(a) following the paragraph for CRF:

<u>the four CONE Regions.</u>		
Notwithstanding the use of the formula above, Market Sellers also have the option of providing alternate tax rates and or depreciation schedules consistent with the tax rate and depreciation used in filing taxes to arrive at a unit specific CRF that appropriately matches the Market Seller's actual tax and depreciation treatment.
