New Attachment G included recommended notification forms.</p>	

- (2) Option-to-Build project's title transfer process – Line up the manual language with the associate Tariff provision.
- (3) Periodic Cost Tracking Process for Baseline and Supplemental Upgrade Projects – Add new sections for Baseline and Supplemental projects on the requirement and cost update milestones through the projects' implementation phase.
