Administration (9:00 – 9:15)

- 1. Rebecca Carroll, PJM, called the meeting to order. Marilyn Jayachandran, PJM, reviewed the Antitrust, Code of Conduct, media participation, WebEx and In-person meeting participation guidelines.
- 2. Rebecca Carroll reviewed and stakeholders approved the January 10, 2022 Planning Committee (PC) Agenda.
- 3. Marilyn Jayachandran reviewed and stakeholders approved the draft December 6, 2022 Planning Committee meeting minutes.
- 4. Marilyn Jayachandran reviewed the 2023 PC work plan.

Endorsements (9:15 -9:50)

5. Capacity Interconnection Rights for ELCC Resources

Brian Chmielewski, PJM, reviewed the solution packages from the work done in the PC special session on Capacity Interconnection Rights (CIR) for ELCC Resources.

The committee endorsed the Package I with 196 (82%) in favor, 42 (18%) opposed, and 0 abstentions. A second vote showed stakeholders preferred Package I over status quo with 170 (71%) in favor, 68 (29%) opposed, and 0 abstentions.

The committee did not endorse the following packages:

Package D with 83 (35%) in favor, 155 (65%) opposed, and 0 abstentions. A second vote showed stakeholders did not prefer Package D over status quo with 72 (31%) in favor, 162 (69%) opposed, and 4 abstentions.

Package E with 57 (24%) in favor, 180 (76%) opposed, and 0 abstentions. A second vote showed stakeholders did not prefer Package E over status quo with 58 (24%) in favor, 180 (76%) opposed, and 0 abstentions.

Package G with 17 (7%) in favor, 221 (93%) opposed, and 0 abstentions. A second vote showed stakeholders did not prefer Package G over status quo with 21 (9%) in favor, 217 (91%) opposed, and 0 abstentions.

Package K with 65 (29%) in favor, 157 (71%) opposed, and 16 abstentions. A second vote showed stakeholders did not prefer Package K over the status quo with 66 (30%) in favor, 157 (70%) opposed, and 15 abstentions.

Package I will move to the Market and Reliability Committee (MRC) as the Main Motion.
