Administration (1:00 - 1:10)

- 1. Scott Baker opened the meeting and reviewed the agenda.
- 2. Hamad Ahmed reviewed the meeting participation guidelines. The minutes from the 2nd DIRS meeting on September, 10th 2020 were approved with 0 objections and 0 abstentions.
- 3. Scott Baker reviewed the DIRS work plan.
 - Scott Baker stated that the issue "DER Aggregation" has been added to the work plan per FERC's order no. 2222.

Public Distribution Microgrids (1:10 – 1:25)

- 4. Scott Baker presented a timeline and process for stakeholder approval of the manual changes associated with Package C.
 - Scott Baker stated that the first read for the manual changes would be at the MIC and OC on November, 5th 2020 and November 6th 2020, respectively. PJM expects the endorsements to be in December 2020.

FERC Order 2222 – DER Aggregation (1:25 - 1:55)

- 5. Thomas DeVita provided a summary of Order 2222, PJM's compliance directives, and the timeline associated with compliance.
 - Thomas DeVita provided procedural recap, reviewed key terms and discussed 10 key compliance directives.
 - Thomas also discussed provisions applicable to small utilities and the implications of the order on the interconnection of DERs. Lastly, Thomas provided a compliance timeline highlighting that each RTO/ISO must file their tariff changes within 270 days after the Federal Register publication date of the rule.
