Demand Response Subcommittee PJM Conference and Training Center December 12, 2016 9:30 a.m. – 11:20 p.m. EPT

Administration

- 1. Welcome, Announcements and Anti-trust and Code of Conduct announcement
 - A. Roll was called.
 - B. Prior minutes from the 11/11/2016 meeting were approved without modification.

CP Non-Summer CBL Process

2. Mr. Pete Langbein, PJM, provided an update the recent seasonal capacity resource filing, highlighting changes to the filing since the last DRS meeting. There are two pieces to the filing. a) new Summer Period product effective 2020/2021 b) Capacity Performance M&V changes which include summer vs winter nomination (with Winter Peak Load and Winter FSL). For any 2017/2018 registrations, CSP with Capacity Performance registrations are requested to input them as per current rules, then if FERC order a change to the M&V, a process will be developed to augment the registration with the Winter Peak Load and Winter FSL.

Emergency Energy M&V

3. Mr. Jack O'Neill, PJM, reviewed how Emergency Energy M&V will be implemented which became effective on 11/1/2016. All registration will use the default CBL Method of Standard 3 Day Type with SAA and do not need to submit a CBL Test (RRMSE), instead of the hour before method. CSPs will not have to update or change their registrations as PJM will be updating the CBL Method on the registrations as necessary.

DR Load Management Open Registration

Mr. Pete Langbein, PJM, reviewed components that changed on the matrix since the last meeting. Termination language was broken out into a component and testing requirements and replacement capacity rules were discussed.

DR Hub Update

4. Ms. Andrea Yeaton, PJM, gave an update on DR Hub (eLRS replacement). The Train UI release will be implemented on 1/12/2017. A data refresh from production will be done shortly before the implementation and users are asked to verify their data came over correctly. Training on the UI will be

announced shortly. The production release is still targeted for 4/2/2017. CSPs are reminded that the current Web Services Soap protocol for eLRS will not work in DR Hub and that a switch must be made to use the Rest protocol. Details can be found on the DR Hub web page at:
