Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct, Public Meetings/Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the July 22, 2021 MSS meeting.

Sean Flamm, PJM, provided details on a Settlement C processed in the August 2021 invoice and an upcoming Settlement C that will be processed in the September 2021 invoice. In the August 2021 invoice, there were adjustments for December 2019, January 2020, and February 2020 load data that affected the DAY area. In the September 2021 invoice, adjustments will affect the DAY area for load data for March 2020, April 2020, and May 2020.
