Administration

Mr. Dave Anders opened the meeting and reviewed the agenda.

Ms. Amanda Egan collected attendance, provided the Anti-trust and Code of Conduct announcements.

Reference Price

Mr. Stu Bresler presented a revised sensitivity analysis (previously contained in the final slide of the posted "PJM Analysis" presentation), based upon the posted RPM sensitivity analysis PJM issues annually following the Base Residual Auction. He indicated the revisions were necessary to correct technical issues and also resolve any misimpressions, specifically stating that the sensitivities do not reflect potential impacts of any proposal in any specific Locational Deliverability Area, nor do they reflect anticipated quantities of subsidized resources depending on how such resources are defined as part of any proposal.

Package Proposals

PJM and NRG reviewed their previously discussed proposals with stakeholders. LS Power and AMP provided updates on their proposals based on feedback received at the August 2 and 3 CCPPSTF meetings. Additionally, Monitoring Analytics (the Independent Market Monitor (IMM)), ODEC, NRDC, Exelon, and Dayton Power & Light (Capacity Choice) reviewed package proposals with the group.

Mr. James Wilson, Wilson Energy Economics, provided a presentation offering his perspective on the applicability of MOPR for certain resources as well as commentary on two-tiered pricing as highlighted in many of the proposals under consideration by the task force.

Repricing Triggers

Mr. Anders reviewed the results of the poll on potential repricing triggers with stakeholders. After discussion with participants, it was determined that the poll results should be dismissed from consideration.

The group began the process of identifying and documenting potential repricing triggers, and identified trigger design components. The group will review this list at an upcoming meeting and will have the opportunity to add proposed trigger options/proposals.

Dr. Anthony Giacomoni provided updates to information on Key Work Activity #3. Based on discussion with participants, this item is now closed.
