



Carbon Pricing Senior Task Force (CPSTF) Final Report

November 2021

Issue Creation

[Problem Statement](#) and [Issue Charge](#) brought forward by Eastern Generation, Public Service Electric & Gas, CPV Power Holdings, NextEra Energy Marketing, and Dayton Power & Light Company and approved at the April 25, 2019 Markets and Reliability Committee (MRC).

Issue Summary

The [Carbon Pricing Senior Task Force \(CPSTF\)](#) was established to discuss and explore potential process or rule changes necessary to manage emissions leakage and integrate a regional or sub-regional carbon pricing mechanisms into PJM's energy market design, where appropriate.

Stage 1 of the key work activities included education on various topics as well as the review of PJM and other stakeholder and industry analyses and potential solutions. Educational topics included presentations by PJM and many others in the industry on carbon pricing concepts, the Regional Greenhouse Gas Initiative (RGGI), a review of RPS standards and goals around the PJM region, leakage mitigation efforts in other regions of the country, state/federal jurisdictional issues, a review of then-pending legislation around a clean energy standard, and development of cost-based offers in PJM and inclusion of emission-based costs in such offers. On the analysis side, PJM presented its study on carbon pricing (using high & low RGGI scenario prices) and potential leakage mitigation options. Other analyses and potential solution ideas were presented by MJB&A/EDF, Monitoring Analytics, Exelon, Vistra, and E3/EPSC. See here for [Leakage Mitigation Study Comparisons](#)

Stage 2 of the key work activities was targeted to include the development of a common set of rules to integrate carbon pricing and manage leakage, where appropriate. Stage 2 of the key work activities has not been initiated.
