PJM Interconnection Capacity Senior Task Force (CSTF) PJM Conference and Training Center September 24, 2013; 9:30 – 4:30 (Meeting #35)

1. Administration (9:30 – 9:45)

Mr. Baker called the meeting to order. Ms. Fabiano called roll and reviewed the draft minutes from September 18, 2013 (meetings #34). Meeting minutes were approved and will be posted as final. Mr. Baker briefly reviewed the agenda and the CSTF Work Plan.

Stakeholders reviewed and discussed new solution options submitted to the Facilitation Team, documented additional solution options, and began packaging solutions.

3. DR as an Operational Capacity Resource (10:45 – 4:00) (issue tracking)

A. Clearing of Limited DR in RPM (10:45 – 12:15; 1:00 – 2:00)

Mr. Wilson, Wilson Energy Economics, provided his perspective on the Hobbs analysis. Professor Hobbs and Mr. Wilson took questions over the phone.

Mr. Schofield, Customized Energy Solutions, presented an alternate solution option to PJM's for clearing resources in RPM.

Stakeholders began documenting design components and status quo in the solutions matrix related to this issue.

B. Operational DR (2:15 – 4:15)

Mr. Baker presented two updates to options proposed by PJM in the matrix.

Stakeholders discussed the solution options in the matrix, and are asked to submit any additional design components or solutions in advance of the October 4 meeting.

Mr. Keech presented follow-up items requested at the September 9th meeting related to certain design components and solution options.
