# 1. <u>DR CAPACITY MARKET TRANSITION MECHANISM FOR NEW 30 MINUTE LEAD TIME</u> REQUIREMENT (0910 - 0920)

Mr. Pete Langbein, PJM, will offer for stakeholder consideration, a potential timeline to vote on the proposed transition mechanism that would allow curtailment service providers that are unable to deliver amounts of demand response previously cleared in PJM's capacity auctions to be relieved of part, or all of, their obligation and have their capacity payments commensurately reduced accordingly.

### 2. POLL RESULTS AND NEXT STEPS (0920 – 0950)

Ms. Ford will review the results of the poll taken by the task force participants on the solution packages and specific design components, as they relate to the Triennial Review. She will then discuss next steps with the task force which include a vote to be conducted early next week, followed by a vote at the Markets and Reliability Committee, scheduled to take place on August 21.
