To Whom it May Concern:

Thank you for your letters regarding the Independence Energy Connection West market efficiency transmission project. PJM appreciates your concerns and respects the collective implications this project has on both the residents of Franklin County and the larger region.


We recognize that PJM's Independent Market Monitor does not support the very concept of market efficiency transmission projects. However, PJM is obligated to implement its governing documents and tariffs that have been approved by the Federal Energy Regulatory Commission. As part of its tariff obligations to maintain and plan the grid, PJM is required to evaluate economic congestion on the system and identifies solutions to mitigate that congestion. In this case, the Independence Energy Connection project had been selected to relieve congestion so that electricity can continue to be delivered economically to consumers in the region.

Once a project is selected, PJM defers to the role and authority of the states related to siting for the project. The project developer has the responsibility to select the route, obtain siting approval from state agencies, obtain right-of-way and easements from property owners, and construct and operate the line.

PJM has testified in both Pennsylvania and Maryland and is working collaboratively with the two states to clarify the need for these facilities. This process will continue into 2020.

Again, PJM appreciates your concerns, and I hope this correspondence sheds some light on PJM's role in the Independence Energy Connection West project.
