3. Monitoring Analytics (MA) 2018 Budget – Dr. Bowring presented the proposed 2018 MA budget for operating expenses and capital expenditures.
4. NERC and RFC 2018 Budget – Mr. Jones presented the 2018 budgets for NERC and RFC and the resulting assessments to the PJM membership.
5. PJM 2018 Budget – Mr. Snow confirmed with the PJM FC that the OPSI and CAPS 2018 proposed budgets aligned with preliminary values presented to the committee. The OPSI Board had approved the 2018 OPSI budget. The CAPS board would finalize the 2018 budget on 9/27/17.
