5. First Quarter 2018 PJM Financial Statement Review – Ms. Heater reviewed highlights from PJM's unaudited financial statements as of and for the three months ended March 31, 2018.
6. First Quarter 2017 Financial Review – Mr. Snow reviewed the net operating expenses, service category charges, and capital spending for the quarter ended March 31, 2018. Requests were made for additional information on subsidiary company information and PJM staffing in future quarterly reporting. PJM agreed to update information provided to meet member requests.
