## Administration

1. Mr. Steve Herling, PJM, called the meeting to order and asked if the Planning Committee had any additional items for the agenda. There were no suggestions for additional agenda items. 2. Mr. Herling asked Ms. Bridgid Cummings to review the meeting minutes of the February 9, 2017 Planning Committee meeting. Mr. Herling asked the Planning Committee to approve the minutes. Mr. Carl Johnson made a motion to approve the minutes. Mr. John Kopinski seconded the motion. In a voice vote, the Planning Committee approved the February 9, 2017 Planning Committee Minutes.

## First Readings

### 3. **Manual 14B Update for Remedial Action Scheme**

Mr. Mike Herman, PJM, presented red-line changes to Manual 14B (PJM Region Transmission Planning Process) related to Baseline Thermal Analysis, PRC-023 requirements, and references to SPS (Special Protection System) changed to RAS (Remedial Action Scheme). Additional red-line changes will be posted regarding the handling of energy efficiency; this change is being made to reflect current practices given approval of the energy and saturation variables in the long term load forecast (11/2015). This will be brought to the next Planning Committee meeting for endorsement.

### 4. **PJM Manual 14F**

Mr. Herman, PJM, reviewed the proposed draft of Manual 14F (PJM Competitive Planning Process Manual). This manual will be brought to the next Planning Committee meeting as a first read, but members are strongly encouraged to provide feedback prior to the April meeting. Ms. Christina Catalano, PJM, reviewed the Decisional Process Map. Members are asked to please provide feedback and recommendations in regards to this as well.

## Informational Updates

### 5. **TEAC Redesign Update**

Ms. Amanda Long, PJM, reviewed the TEAC Redesign efforts. The Tech Change Forum Community Tool, using the same technology as the Planning Community, will be rolled out at the Tech Change Forum on March 21<sup>st</sup> and 22<sup>nd</sup>. External users may begin to receive automated responses from the Planning Community Tool in response to submitted questions to [RTEP@pjm.com](mailto:RTEP@pjm.com) and other planning email addresses.

## 6. DEDSTF Update

Mr. Herman, PJM, provided an update on the work being addressed by the DEDSTF (Designated Entity Design Standards Task Force). The standards, developed in sub-groups, are being combined into a single document which will be brought to the PC for a first read in April.

## 7. MOD-032 Documentation Review

Mr. Jonathan Thompson, PJM, provided an update on MOD-032, the schedule for Transmission Owners, and 2017 activity related to the Gen Model tool. Mr. Thompson also reviewed changes to the MOD-032 documentation. The document is available on the [PC Website](#) under the March 9<sup>th</sup> meeting materials.

## 8. Geomagnetic Disturbance Update

Mr. Stanley Sliwa, PJM, provided an update of the TPL-007-1 Standard related to Transmission System Planned Performance for Geomagnetic Disturbance Events. There was a review of the implementation schedule and the vulnerability assessment process. Mr. Sliwa also reviewed each of the requirements and expected deadlines for each.

## 9. Winter Season Resource Adequacy and Capacity Requirements

Mr. Tom Falin, PJM, provided an update on winter season resource adequacy analysis. He reviewed that there are three key work activities: winter peak load forecasting; winter season resource adequacy; and winter season reliability requirements. Analysis will be coordinated through the Planning Committee and the Resource Adequacy Analysis Subcommittee. The next RAAS meeting is March 31, 2017 from 2pm to 4pm.

## 10. Generator Interconnection NOPR Update

Mr. Dave Egan, PJM, provided an update regarding the Generator Interconnection Notice of Proposed Rulemaking. A one month extension was granted for responses to the NOPR and PJM will be providing a response by the April 13<sup>th</sup> deadline.

## 11. NERC/RRO Update

Mr. Preston Walker, PJM, provided an update on recent NERC activities and PJM compliance activities.
