Administration

Mr. Chuck Dugan welcomed stakeholders. Mr. Neil Smith, chair of the Board CEO Search Committee provided an update on the CEO search.

- A. Mr. David Anders announced the following new member companies approved for PJM membership since the last meeting, bringing the total membership to 1043:
 - Central Electric Power Cooperative, Inc. (Voting Member) selected the Other Supplier sector
 - Hillcrest Solar I, LLC (Affiliate Member) selected the Generation Owner sector
 - Lexington Chenoa Wind Farm LLC (Affiliate Member) selected the Generation Owner sector
 - Verano Energy Trading, LP (Voting Member) selected the Other Supplier sector
 - Mr. Anders noted that four members had withdrawn since the last meeting.
- B. Mr. Anders confirmed the presence of a quorum.
- C. Mr. Anders reminded participants of Antitrust and Code of Conduct requirements.

Endorsements/Approvals

1. PJM Manuals

Ms. Rebecca Carroll presented proposed revisions to Manual 34: PJM Stakeholder Process developed through the Stakeholder Process Super Forum. She reviewed proposed friendly amendments to the Critical Issues Fast Path (CIFP) proposal offered by Mr. Greg Poulos on behalf of the DC Office of the Peoples' Counsel and Dr. Joe Bowring, Monitoring Analytics. There were no objections to these proposed amendments being considered friendly and therefore they were incorporated into the proposal. Ms. Carroll also noted that should the CIFP be initiated in the future, PJM will ensure notification will be provided to all stakeholders, including Members, state representatives and OPSI. Finally, she noted several ministerial changes to the posted Manual 34 revisions that address grammar, typos and non-material updates to several figures. Following discussion the proposed Manual 34 revisions were approved by acclamation with one objection and no abstentions.





2. Nominating Committee

Mr. Anders presented candidates for the sector representatives on the 2019-2020 Nominating Committee (NC). He noted that members of the NC are bound by a charter and code of conduct specific to the NC. Each member signs a certification attesting to their understanding of the charter and code. The NC Code of Conduct requires that NC members agree to act and undertake decisions that are in the best interests of the PJM enterprise. He noted that while members are expected to solicit input from their sectors, in sitting on the NC they are not acting on behalf of their own company's interests or on behalf of their sector's interests; they are serving alongside the board members as representatives of PJM itself, and are expected to evaluate candidates for the board based on what they believe advances PJM's best interests. Following discussion, the committee **elected** the following sector representatives to the 2019-2020 NC by acclamation with no objections or abstentions:
