Endorsements/Approvals

1. Five Minute Dispatch and Pricing

Steve Lieberman noted the endorsement of this issue at the July 23, 2020 Markets & Reliability Committee meeting, and that a same day vote was requested of the Members Committee (MC). Greg Poulos, CAPS, objected to voting on the same day. Steve Lieberman noted that given the objection, in accordance with PJM Manual 34: PJM Stakeholder Process the MC vote would occur at the September 17, 2020 meeting. Jason Barker, Exelon, moved and Alex Stern, PSEG, seconded suspending the rules to allow the same day vote. The motion to suspend the rules **passed** in a sector-weighted vote with 3.53 in favor. Following discussion, the proposed solution and associated Tariff and Operating Agreement revisions were **endorsed/approved** by acclamation with three objections and three abstentions.
