Members Committee (MC) Chair Steve Lieberman welcomed stakeholders.

Endorsements/Approvals (12:40-1:10)

1. <u>Capacity Capability Senior Task Force Proposed Solution (12:40-1:10)</u>

Steve Lieberman reviewed the actions of the Markets & Reliability Committee (MRC) at its meeting on September17, 2020, noting that Package D as amended by the posted Alternate Motion Amendment to Joint Stakeholder Package was endorsed in a sector-weighted vote with 3.98 in favor.



David Scarpignato, Calpine, proposed a friendly amendment to Package D to incorporate the first part of the posted Alternate Motion Amendment to Joint Stakeholder Package as modified below:

Agreement to Further Evaluate the Operations of Limited Duration Resources

Following FERC approval of an ELCC-related filing that includes a 4-hour Limited Duration Class, PJM will initiate a stakeholder process to further evaluate the coordination of the operation of <u>all</u> Limited Duration Capacity Resources with system needs <u>and evaluate the modelling of Limited</u> <u>Duration Resources within ELCC</u>. The proceeding will consider rules to sufficiently ensure that the operational behavior of Limited Duration Capacity Resources is appropriately aligned with the resource adequacy construct and system reliability by examining issues including but not limited to <u>ELCC modelling</u>, bidding, operations, emergency procedures, and energy market offer requirements.

Sean Baur, GlidePath Power Operations LLC, objected to this being friendly, and therefore it was incorporated into the main motion.

Dr. Paul Sotkiewicz, Elmwood Energy, objected to voting on the same day as the MRC. Adrien Ford, ODEC, moved and Brian Kaufman, Enel X, seconded to suspend the rules to allow a vote on the same day as the MRC. The motion to suspend the rules **passed** in a sector-weighted vote with 4.23 in favor.

Following discussion, Package D as amended by the posted Alternate Motion Amendment to Joint Stakeholder Package was **endorsed** by the MC in a sector-weighted vote with 4.05 in favor.
