Stephanie Monzon, PJM, reviewed the November 2020 PJM operating metrics slides. Metrics will include PJM's load forecast error, BAAL performance, and transmission / generation outage statistics.

## Endorsements (9:30-11:00)

4. Black Start Unit Testing, CRF, Involuntary Termination, MTSL and Substitution Rules
  - a. Dr. Paul Sotkiewicz, Elwood Energy (motion) and Sharon Midgley, Exelon (second) reviewed the proposed amendments to the Black Start Issue Charge to remove retroactive application of proposed CRF changes. **The amendments were approved by the Operating Committee with 151 (63%) in favor, 89 (37%) opposed, and 3 abstained.**

With the amended issue charge, the Chair deemed the application of the CRF change to existing Black Start resources out of Scope. Dr. Joe Bowring, IMM, made the following changes to the IMM solution package to conform to the update Issue Charge: The updated CRF rates and commitment periods would apply only to new Black Start resources. An updated presentation has been posted to PJM.com to reflect these updates.

- b. Becky Davis, PJM, reviewed the solution packages (PJM solution package, IMM solution package, PJM Option 1 solution package, and Dominion solution package) for the Black Start issue. The Operating Committee voted on these packages; **the PJM Option 1 package (83% in favor) will**

**move forward to the MRC as the main motion, the Dominion package (82% in favor) will move forward as the secondary motion.**

Dr. Paul Sotkiewicz requested that the non-binding poll on preference over status quo be taken on both the PJM Option 1 package and the Dominion package, Chair Phillips accepted this request and the non-binding poll was performed on each package.

Voting results were as follows:

- PJM solution package: 92 (43%) in favor, 122 (57%) opposed, 13 abstained
- IMM solution package: 16 (7%) in favor, 208 (93%) opposed, 4 abstained
- PJM Option 1 solution package: 187 (83%) in favor, 39 (17%) opposed, 2 abstained
  - Prefer this package over status quo: 138 (70%) in favor, 60 (30%) opposed, 12 abstained
- Dominion solution package: 184 (82%) in favor, 40 (18%) opposed, 4 abstained
  - Prefer this package over status quo: 163 (73%) in favor, 61 (27%) opposed, 1 abstained
