## Administration

David Scarpignato, Members Committee (MC) Chair, welcomed stakeholders to the meeting. Paula Conboy, PJM Board of Managers, discussed the expiration of the contract for Independent Market Monitoring (IMM) services at the end of 2025. She noted Board’s intention to receive stakeholder feedback on the contract terms, and requested for an item to be placed on the agenda for a future MC meeting for Members to provide the Board with feedback.
