Administration

David Scarpignato, Members Committee (MC) Chair, welcomed stakeholders to the meeting. He informed the MC of the discussion at the March 20, 2023 Stakeholder Process Forum where Members present considered and were in consensus in favor of extending discretion to the MC Chair, Vice Chair and Secretary to move the start time of future MC meetings earlier in the event that the preceding Markets & Reliability meeting ends earlier than expected. In circumstances when the Chair, Vice Chair and Secretary determine that the MC start time should be advanced, adequate notice should be given via email to the MC distribution list. No Members objected to this protocol.

Chris O'Hara discussed a deficiency notice received on March 21, 2023 in Docket No. ER23-1058-000, related to remedies in response to an Event of Default, or potential Event of Default, of a Market Participant. He noted that PJM intends quickly to file the associated clarifications, and request expedited treatment from the FERC.
