Administration

1. Rebecca Carroll, PJM, called the meeting to order. Ashwini Bhat, PJM, reviewed the Antitrust, Code of Conduct, media participation, WebEx and In-person meeting participation guidelines.
2. Ashwini Bhat reviewed and **the committee approved the draft minutes from the September 12, 2024 Planning Committee by acclamation with 0 objections and 0 abstentions.**

Endorsements

3. Manual 21B - PJM Rules and Procedures for Determination of Generating Capability

Josh Bruno, PJM, provided a second read of the Manual 21B revisions as part of the conforming changes for the amended “Gas Combined Cycle Dual Fuel Class” and “Gas Combustion Turbine Dual Fuel Class” RAA definitions. **The committee endorsed the manual changes by acclamation with 0 objections and 0 abstentions.**

4. Enhancing Capacity Interconnection Rights (CIR) Transfer Efficiency

- A. Joe Bowring, IMM, presented a proposal package on behalf of IMM.
- B. Tonja Wicks, Elevate Renewable Energy, presented a proposal package on behalf of Coalition.

A friendly amendment was made to the Coalition proposal package solution option under the design component no.9 in the Matrix and to their presentation slide no.3. David Scarpignato, Calpine Energy Services, proposed an amendment as follows.

...i.e., **nuclear and combined cycles**, are eligible resources for replacement **and allowed COD more than 3 years from the date of cessation of the Existing Generation Facility or signed execution of the GIA, whichever occurs last.**

There were no objections, and therefore the amendment was incorporated into the proposal package in the Matrix and presentation slides.

- C. Ed Franks, PJM, presented a proposal package on behalf of PJM.

[Issue Tracking: Enhancing Capacity Interconnection Rights \(CIR\) Transfer Efficiency](#)

The committee endorsed the following package as amended:

- **Coalition Package with 141 (51.8%) in favor, 131 (48.2%) opposed, and 3 abstentions. A second vote showed stakeholders preferred the Coalition Package over status quo with 138 (51.7%) in favor, 129 (48.3%) opposed, and 7 abstentions.**

The committee did not endorse the following packages:

- IMM Package with 30 (11.1%) in favor, 240 (88.9%) opposed, and 5 abstentions. A second vote showed stakeholders did not prefer the IMM Package over status quo with 30 (11.2%) in favor, 239 (88.8%) opposed, and 6 abstentions.
- PJM Package with 104 (40.6%) in favor, 152 (59.4%) opposed, and 19 abstentions. A second vote showed stakeholders preferred the PJM Package over status quo with 143 (59.8%) in favor, 96 (40.2%) opposed, and 7 abstentions.

The Coalition Package will move to the Markets & Reliability Committee as the Main Motion.

First Reads

5. Capacity Markets Enhancement - Capacity Emergency Transfer Limit (CETL)

Tom Hoatson, LS Power, provided a first read of the Issue Charge and Problem Statement to develop a solution to align the CETL with the shift in risk from the summer peak to the winter period. **The committee will be asked to endorse the Problem Statement and approve the Issue Charge at its next meeting.**

6. Reliability Resource Initiative

Paul McGlynn and Donnie Bielak, PJM, introduced PJM's concept of a focused, transitional and temporary interconnection process for resources with higher capacity factors to help maintain the diversity and reliability of the PJM system.

7. Reliability Compliance Update

This item was changed to an informational posting at the meeting. An updated version of the material was posted on the PC page on PJM.com after the meeting.
