#### Administration

Ms. Diane Antonelli, PJM, provided welcome, announcements and review of WebEx guidelines as well as of the Antitrust, Code of Conduct, and Public Meetings/Media Participation Guidelines.

# KWA#4 CBIR Process

Mr. Glen Boyle, PJM, reviewed PJM's position on KWA#4 items with stakeholders. Discussion was held regarding continuation of work on KWA#4 or a potential hiatus of this group until FERC provides their ruling on KWA#3 filing and related issues such as market mitigation are discussed in other stakeholder forums. Stakeholders indicated their preference to continue working through the items for KWA#4 at this time.

Mr. Gary Greiner, PSEG, reviewed their <u>proposal</u> for KWA#4. Stakeholders, the IMM and PJM SME's discussed and provided additional input in this regard. PSEG will work with PJM to populate their proposal into the matrix for review at the May 29<sup>th</sup> meeting.

Ms. Keshavamurthy, PJM, led a quick discussion regarding review of the current solution options as part of the CBIR process. Upon discussion with the stakeholders, PJM staff and IMM, it was decided to delay further review of the current solution options until our May 29<sup>th</sup> meeting as PSEG will be reviewing the updated matrix incorporating their proposal.

### Meeting Recap and Future Agenda Items

Ms. Keshavamurthy, PJM, reviewed action items and next steps:

- 1. PSEG to work with PJM SMEs to populate the KWA#4 matrix with their proposal.
- 2. PSEG to clarify what MWs will be used to calculate the incremental offer for the reference price.
- 3. Stakeholders requested that the IMM review past penalties and provide data on how many instances would be mitigated by the PSEG proposal.
