PJM is consolidating the existing SOUTHEXP/SOUTHIMP interface pricing points to one new SOUTH interface pricing point (PNODEID: 2156111904):

- No change in the definition
- Improves maintainability of the interface
- Addresses a recommendation from the IMM in the State of the Market report to consolidate SOUTH EXP/SOUTH IMP into one interface



PJM has reviewed the SOUTHEXP/SOUTHIMP interfaces

- It has been determined, based on this review, that two interfaces will be consolidated to one new SOUTH interface using the same definition
  - No pricing change under this consolidation
- As a result, the new SOUTH interface will be effective June 1, 2021
