Administration (9:00-9:05)

Mr. Kormos welcomed stakeholders to the meeting and Mr. Anders provided the Anti-trust and Code of Conduct announcements.

Endorsements/Approvals (9:05-10:30)

1. Draft Minutes (9:05-9:10)

Minutes of the September 24, 2015 Markets and Reliability Committee (MRC) meeting were **approved** by acclamation with no objections or abstentions.

2. PJM Manuals (9:10-9:30)

- A. Mr. Mike Sitarchyk reviewed changes to Manual 40: Certification and Training Requirements.
- B. Mr. David Schweizer reviewed changes to Manual M10: Pre-Scheduling Operations.
- C. Mr. David Schweizer presented revisions to Manual 14D: Generator Operational Requirements which incorporate the results of the Cold Weather Resource Improvement process survey.
- D. Mr. Mike Herman reviewed revisions to Manual 14 series manuals regarding Multi-Driver Approach.

Following discussion, the proposed revisions in items 2.A through 2.D were **endorsed** by acclamation with no objections or abstentions.

3. Price Formation (9:30-10:30)

- A. Mr. Stan Williams reviewed elements of the recently FERC issued Notice of Proposed Rulemaking (NOPR) related to price formation regarding sub-hourly settlements. He noted the many implications for PJM and Member system updates, as well as the timeline for response to the NOPR and ultimately implementation of any resulting FERC order.
- B. Mr. Adam Keech reviewed elements of the recently FERC NOPR related to price formation regarding shortage pricing. He also noted the timeline for response to the NOPR and ultimately implementation of any resulting FERC order.
- C. Ms. Adrien Ford reviewed the recently FERC issued NOPR related to price formation and the potential relationships with the Energy Market Offer Cap. She noted that in the NOPR the FERC indicated their intention to issue additional guidance related to the Energy Market Offer Cap requirements.
- D. Ms. Ford reviewed the history of Energy Market Offer Cap concerns and stakeholder actions, and noted the July 2015 request of the PJM Board of Managers for renewed stakeholder efforts toward reaching consensus on an update to the Offer Cap. She discussed stakeholder activities since the

Board request including consideration at the Market Implementation Committee, Members Committee Webinar, and regular and special MRC meetings. She noted that four individual proposals had been developed by stakeholders and vetted at the special MRC meetings. The four proposers had met in an effort to develop a pathway toward consensus, and produced a Potential Consensus Framework proposal which was reviewed at the September 24, 2015 special MRC meeting.

Ms. Ford reviewed the elements of the Potential Consensus Framework proposal. She provided two clarifications in response to questions received from stakeholders: that for cost-based offers greater than the proposed cap, PJM would dispatch units in merit order; and that PJM would produce a report on any events in which offers would be made greater than \$1,000. Mr. Anders discussed the voting protocols, and indicated that each of the four proposers have committed to withdraw their proposals should the Potential Consensus Framework reach supermajority support. Mr. Jeff Whitehead, Direct Energy, Mr. Steve Lieberman, ODEC, Mr. Dave Scarpignato, representing P3, and Dr. Joe Bowering, Independent Market Monitor, each confirmed their support for the Potential Consensus Framework proposal.

Following discussion the Potential Consensus Framework proposal was **endorsed** in a sector-weighted vote with 4.30 in favor.

First Readings (10:30-1:00)

4. Regulation Performance Impacts (10:30-10:50)

Mr. Eric Hsia presented the proposed resolution to operational regulation performance issues. The committee will be asked to endorse the associated revisions to Manual 11: Energy & Ancillary Services Markets Operations at its next meeting.

5. Regulation Market Issues Sr. Task Force (RMISTF) (10:50-11:05)

Mr. Dave Anders presented the draft charter for the RMISTF. He noted the proposed addition of six specific scope items highlighted in the proposed charter. These items were originally included in the Operating Committee's consideration of the issue discussed in item 4 above but were deferred to the RMISTF. The committee will be asked to approve the draft charter at its next meeting.

6. Incremental Auction Tariff Clean Up (11:05-11:15)

Ms. Jen Tribulski presented a Tariff revision for the Incremental Auctions concerning PJM's sale or purchase of capacity necessitated by the Capacity Performance Transition Auctions. The committee will be asked to endorse the proposed Tariff revisions at its next meeting.

7. PAR Task Force Update (11:15-11:30)

Mr. Berner presented proposed solutions regarding PAR transmission and withdrawal rights. The committee will be asked to endorse the proposed solution at its next meeting.

8. RPM Scenario Analysis (11:30-11:45)

Mr. Jeff Bastian discussed plans for the annual RPM scenario analysis. He asked that stakeholders submit any additional scenario requests to the RPM hotline, and indicated that the final scenario list would be discussed with the committee at its next meeting.

9. Load Forecast Update (11:45-12:05)

Mr. Tom Falin reviewed proposed revisions to the PJM load forecast model. Mr. Jeff Bastian discussed associated revisions to Manual 18: PJM Capacity Market and Manual 18B: Energy Efficiency Measurement & Verification. These proposed revisions will be provided for a first read at the next MRC meeting. Mr. Kormos indicated that an additional meeting would be scheduled to allow greater stakeholder understanding of the proposals.

10. Preliminary 2015 IRM Study Results (12:05-12:20)

Mr. Tom Falin reviewed preliminary 2015 IRM Study Results. The committee will be asked to endorse the 2015 IRM Study Results at its next meeting.

11. Underperformance Risk Management in RPM/CP (12:20-12:35)

Mr. Bob O'Connell, on behalf of the members of the Supplier Caucus, discussed a proposed Problem Statement and Issue Charge related to Underperformance Risk Management in RPM/CP. The committee will be asked to approve the proposed Problem Statement and Issue Charge at its next meeting.

12. Events Out of Seller's Control (12:35-12:50)

Mr. Ken Foladare, on behalf of the members of the Supplier Caucus, discussed a proposed Problem Statement and Issue Charge related to Events Out of Seller's Control. The committee will be asked to endorse the proposed Problem Statement and Issue Charge at its next meeting.

13. PJM Manuals (12:50-1:00)

A. Mr. Mark Sims presented proposed Manual 14B: PJM Regional Transmission Planning Process revisions regarding Winter Reliability Criteria in Planning. The Committee will be asked to approve these proposed revisions at its next meeting.
