Administration

Ms. Daugherty and Mr. Anders welcomed the participants, and provided the announcements and antitrust and code of conduct announcements.

Endorsements/Approvals

1. Draft Minutes

Minutes of the December 22, 2016 meeting of the Markets and Reliability Committee (MRC) were **approved** by acclamation with no objections or abstentions.

2. PJM Manuals

- A. Mr. Eric Hsia presented revisions to Manual 11: Energy & Ancillary Services Market Operations and Manual 12: Balancing Operations to account for the updated Regulation Requirement developed by the Regulation Market Senior Issues Task Force.
- B. Mr. Ray Fernandez presented revisions to Manual 27: Open Access Transmission Tariff Accounting as part of an annual review process.
- C. Mr. Liem Hoang presented proposed revisions to Manual 38: Operations Planning.
- D. Ms. Kim Sauerwine presented proposed revisions to Manual 40: Training and Certification Requirements.

Following discussion, item 2.A was **endorsed** by acclamation with one objection and one abstention. Item 2.B was **endorsed** with no objections and one abstention. The committee **endorsed** the proposed revisions in items 2.C and 2.D by acclamation with no objections or abstentions.

3. PJM Capacity Problem Statement / Issue Charge

Mr. Ed Tatum, American Municipal Power, presented an updated problem statement / issue charge regarding PJM Capacity. Mr. Bob O'Connell proposed a friendly amendment (which was posted on PJM.com) to change references to "state actions" to "out of market" in the problem statement and issue charge. Mr. Tatum indicated that this was not considered friendly, and Mr. O'Connell requested that his revised problem statement and issue charge be considered an alternate proposal. Following significant discussion, the sponsoring group updated/amended the main motion, which was posed on PJM.com. Following discussion, the committee approved the proposed problem statement / issue charge sector-weighted vote with 3.95 in favor.

4. Underperformance Risk Management Sr. Task Force (URMSTF)

Ms. Rebecca Carroll presented proposed revisions to the Tariff and Reliability Assurance Agreement regarding participation as Capacity Performance by resources external to PJM's footprint. Following discussion, the committee the proposal <u>failed</u> revisions in a sector-weighted vote with 2.79 in favor. Mr. Jason Barker moved and Mr. O'Connell seconded an alternate proposal consisting of the URMSTF proposal modified to be applicable only prospectively (existing units being grandfathered). Mr. Horstmann proposed a friendly amendment to limit the motion to only those sections of the proposal that apply to resources desiring to be pseudo-tied, but have not yet cleared a capacity auction, and that the remainder of the original URMSTF proposal to be returned to the URMSTF for additional consideration. Following discussion the committee <u>endorsed</u> the motion in a sector-weighted vote with 3.97 in favor. Ms. Daugherty noted that this proposal will be included on the Members Committee on January 26, 2017 for endorsement.

5. Energy Market Uplift Senior Task Force (EMUSTF)

Mr. Dave Anders, Mr. Stu Bresler and Mr. Adam Keech presented Phase 1 and Phase 2 proposals endorsed by the EMUSTF. Following discussion, the committee **endorsed** the Phase 1 proposal (package A) in a sector-weighted vote with 4.10 in favor. Ms. Stephanie Staska moved and Mr. Wesley Allen seconded postponement of voting on Phase 2 proposals for one year. This motion to defer failed in a sector-weighted vote with 1.2 in favor. Following discussion, the committee **endorsed** the Phase 2 proposal (package Q) in a sector-weighted vote with 3.95 in favor.

6. Market Operations Price Transparency

Mr. Rami Dirani presented a proposed problem statement / issue charge regarding Market Operations Price Transparency. Following discussion, the committee **endorsed** the proposed problem statement / issue charge by acclamation with no objections or abstentions.

7. Operating Parameters

Mr. Tom Hauske reviewed proposed revisions to the PJM Tariff, and Manual 11: Energy & Ancillary Services Market Operations, Manual 12: Balancing Operations, and Manual 28: Operating Agreement Accounting regarding Operating Parameters. Following discussion, the committee **endorsed** the proposed revisions by acclamation with no objections or abstentions.

8. Governing Documents Enhancement & Clarification Subcommittee (GDECS)

Ms. Janell Fabiano presented proposed Tariff, Operating Agreement (OA) and Reliability Assurance Agreement revisions regarding clean-up of definitions. Following discussion, the committee **endorsed** the proposed revisions by acclamation with no objections and one abstention.

9. FERC Order 825 – Shortage Pricing

Mr. Adam Keech reviewed the proposed Shortage Pricing / Operating Reserve Demand Curve solution





and associated manual revisions. The committee will be asked to endorse the proposed package at its next meeting.

10. Transmission Substation Equipment in FERC Order 1000

Mr. Mark Sims discussed Regional Transmission Expansion Plan (RTEP) process enhancements related to the treatment of transmission substation equipment in PJM FERC Order 1000 Proposal Windows and associated Operating Agreement revisions. The committee will be asked to endorse the proposed revisions at its next meeting.

11. <u>Draft Pseudo-Tie Agreements</u>

Ms. Jacqui Hugee reviewed two pseudo-tie agreements and Tariff and OA revisions shown below. The committee will be asked to endorse the proposed agreements and Tariff and OA revisions at its next meeting.

- Pro forma pseudo-tie agreement
- Pseudo-tie reimbursement agreement for pseudo-tie into PJM
- Associated Tariff and OA revisions

12. PJM Manuals

- A. Mr. Ryan Nice reviewed proposed changes to Manual 01: Control Center and Data Exchange Requirements. The committee will be asked to endorse the proposed revisions at its next meeting.
- B. Mr. Jerry Bell presented administrative updates to Manual 22: Generator Resource Performance Indices. The committee will be asked to endorse the proposed revisions at its next meeting.
- C. A revision to *Manual 39: Nuclear Plant Coordination* was posted effective 12/23/2016. This revision includes only changes to the Attachment C: "Plant Specific NPIRs Revision History" reflecting recent plant specific nuclear plant interface requirement (NPIR) changes.
