#### **Endorsements/Approvals**

### 1. Draft Minutes

Minutes of the May 24, 2018 meeting of the Markets and Reliability Committee (MRC) were <u>approved</u> by acclamation with no objections or abstentions.

#### 2. PJM Manuals

- A. Mr. Eric Endress reviewed proposed changes to Manual 11: Energy & Ancillary Services Market Operations. Following discussion, the committee **endorsed** the proposed revisions by acclamation with no objections or abstentions.
- B. Mr. Patricio Rocha-Garrido presented revisions to Manual 20: PJM Resource Adequacy Analysis. Following discussion, the committee **endorsed** the proposed revisions in a sector weighted vote with 4.56 in favor.

#### 3. Governing Document Enhancement & Clarifications Subcommittee Updates (GDECS)

Ms. Jacqulynn Hugee provided a review of changes to clean-up governing agreement cross-references in the Tariff and RAA. Following discussion, the committee <u>approved</u> that future similar changes simply be placed on a new Consent Agenda for the MRC (rather that presented at the MRC) by acclamation with no objections or abstentions, and <u>endorsed</u> the proposed revisions by acclamation with no objections or abstentions. There was no objection to adding this item to the Consent Agenda for the June 21, 2018 Members Committee meeting.

#### 4. FTR Nodal Remapping (9:45-10:00)

Mr. Brian Chmielewski reviewed revisions to Manual 06: Financial Transmission Rights pertaining to the FTR Nodal Remapping issue. Following discussion, the committee **endorsed** the proposed revisions by acclamation with no objections or abstentions.

#### 5. Long Term FTR Auction

Mr. Brian Chmielewski reviewed the Long Term FTR Auction issue, and present PJM's proposed package. Following discussion, the committee **endorsed** the proposed revisions by acclamation with no objection and ten abstentions. There was no objection to adding this item to the Consent Agenda for the June 21, 2018 Members Committee meeting.





### 6. Variable Operations & Maintenance Packages

Ms. Melissa Pilong reviewed the solution packages endorsed at the Market Implementation Committee (MIC) to address the Variable Operations & Maintenance (VOM) Costs issue. Particularly, she presented the main motion (also called the "Default" proposal) and the PJM proposal as the first alternative motion. Mr. Bill Fields moved and Ms. Susan Bruce seconded the Independent Market Monitor's proposal presented at the MIC as the second alternative motion. Mr. Brian Wilkie moved and Mr. Greg Poulos seconded a proposal developed by Rockland Electric Company as the third alternative motion. Mr. Brock Ondayko proposed a friendly amendment to the main motion to eliminate the capability of uncleared capacity resources (and energy only resources) to include their fixed costs in their energy market offers. There were no objections to this proposed friendly amendment and therefore it was incorporated into the main motion. Mr. Ondayko proposed a second friendly amendment to the main motion to keep long-term maintenance for CCs/CTs within RPM, and utilize the RECO values instead of EIA values as safe harbor, and units with higher costs than these values would be expected to provide information to PJM to justify greater values in their cost-based offer - no generating units will be allowed to exceed the Manual 15 VOM estimates unless explicitly approved by providing evidence to demonstrate such costs. Mr. O'Connell objected to this proposed friendly amendment and therefore this proposed friendly amendment was not incorporated into the main motion.

Mr. Mike Borgatti moved and Mr. Wilkie seconded a motion to defer voting on this issue to no later than the September 27, 2018 MRC meeting, and request further discussion at the MIC to foster clarity of the proposed friendly amendments, and to preserve the voting order on the motions. Mr. Robert O'Connell proposed a friendly amendment to change the due date to the August 23, 2018. Mr. Borgatti and Mr. Wilkie confirmed that this was friendly, and therefore the proposed friendly amendment was incorporated into the motion to defer. The committee **approved** the motion with no objections or abstentions.

#### First Readings

#### 7. Governing Document Revisions for Seasonal Demand Response Registration

Ms. Andrea Yeaton and Ms. Terri Esterly presented a first read of revisions to Manual 18: Capacity Market, the Open Access Transmission Tariff (Tariff) and the Reliability Assurance Agreement (RAA) associated with the registration process for aggregated seasonal Demand Response resources. The committee will be asked to endorse the revisions at its next meeting.

#### 8. Revisions to RAA and Manual 18: PJM Capacity Market

Mr. Jack O'Neill reviewed revisions to the RAA and Manual 18: Capacity Market associated with changes developed at the Demand Response Subcommittee to address the Winter Peak Load (WPL) calculation issue assigned by the MIC in October, 2017. The committee will be asked to endorse the revisions at its next meeting.





### 9. Fuel Requirements for Black Start Resources Problem Statement & Issue Charge

Mr. David Schweizer presented a first read of a problem statement and issue charge on Fuel Requirements for Black Start Resources. The committee will be asked to endorse the problem statement and issue charge at its next meeting.

### 10. FTR Credit Proposal

Ms. Bridgid Cummings presented a first read on the FTR Credit proposal developed at the Credit Subcommittee (CS), and the associated Tariff revisions. The committee will be asked to endorse the proposal and Tariff revisions at its next meeting, and the Members Committee will be asked to endorse the proposal at its meeting on the same day.

### 11. PJM Manuals

- A. Ms. Bilge Derin reviewed proposed changes to Manual 01: Control Center and Data Exchange Requirements. The committee will be asked to endorse the manual revisions at its next meeting.
- B. Ms. Diane Lake reviewed proposed changes to Manual 3A: Energy Management System (EMS) Model Updates and Quality Assurance (QA). The committee will be asked to endorse the manual revisions at its next meeting.
- C. Ms. Lisa Krizenoskas presented the split of Manual 14A: New Services Requests Process into revised Manual 14A: New Services Requests Study Process and new Manual 14G: Generation Interconnection Requests. The committee will be asked to endorse the manual revisions at its next meeting.

#### Informational Updates

Ms. Daugherty noted that PJM member GreenHat Energy, LLC was collateral default, and would also be declared in payment default at 5:00 pm June 21, 2018 if they do not pay their currently overdue invoice.

Ms. Daugherty also noted that a member had met its obligation pursuant to the terms of a FERC approved Settlement Agreement to pay a disgorgement of approximately \$31.4 million, and committed that members would receive a follow-up email explaining how these funds would be allocated back to members who had been charged operating reserves during the period to which the disgorgement relates.
