## Endorsements

### 1. Electric Gas Coordination

Susan McGill reviewed the proposed solution endorsed by the Electric Gas Coordination Senior Task Force (EGCSTF) and corresponding revisions to Manual 11: Energy & Ancillary Services Market Operations and Manual 13: Emergency Operations. Following discussion, the proposed solution and associated manual revisions **failed** in a sector-weighted vote with 2.561 in favor.

John Rohrbach, SMECO, moved and Adrien Ford, Constellation Energy Generation, seconded the EGCSTF proposal without the fuel procurement notification requirements. Following discussion, they withdrew their motion.

Paul Sotkiewicz, Elwood Energy, LLC, moved and David Scarpignato, Calpine Energy Services, L.P., seconded the EGCSTF proposal without the fuel procurement notification requirements. Following discussion, the motion **passed** by acclamation with no objections or abstentions.
