1. Enhanced Know Your Customer (KYC)

Eric Scherling reviewed a proposed solution and corresponding Tariff revisions addressing KYC enhancements as endorsed by the Risk Management Committee (RMC). Paul Sotkiewicz, Elwood Energy, LLC, moved and Brad Swalwell, Tangent Energy Solutions, Inc., seconded deferring voting on the proposed solution and corresponding Tariff revisions until the August 21, 2024 meeting. The motion to defer was **approved** by acclamation with two objections and no abstentions. Jennifer Tribulski noted that same day votes will be sought at the August 21, 2024 MRC and Members Committee (MC) meetings.

2. Performance Impact of the Multi-Schedule Model in the Market Clearing Engine (MCE)

Adrien Ford, Constellation Generation, moved and Lynn Horning, AMP, seconded the previously proposed Package B (PJM/GT Power Group) solution addressing the performance impact of the multi-schedule model on the Market Clearing Engine. Following discussion, the proposed solution was **endorsed** in a sector-weighted vote with 3.909 in favor.
