Problem Statement ([link](#)) and Issue Charge ([link](#)) brought forward by Dominion Energy and approved at the Sept. 29, 2021 Markets and Reliability Committee.

ISSUE SUMMARY

The EGCSTF spent several meetings educating stakeholders on various aspects of electric and gas market coordination from diverse perspectives. The Task Force then spent time separating out areas within PJM's control and issues that are controlled by external entities, such as FERC and the natural gas industry. Following Winter Storm Elliott, the Task Force evaluated the challenges observed and recommendations from the PJM and FERC/NERC Reports to better inform potential solution packages.

1. RECOMMENDED PROPOSAL

There are two main components of the recommended proposal:

- Additional transparency and consistency of intra-day real time commitment runs coordinated with the NAESB gas nomination cycles to provide additional opportunities to commit resources based on changing system conditions and generator availability during the operating day.
- Ability for gas generators to update Markets Gateway to confirm if gas supply (1) has been procured or (2) is expected to be available to meet Day Ahead energy and reserve commitments. This will be in effect March 1 through Nov. 30 between 15:00 and 24:00 Eastern Prevailing Time and during periods when Hot Weather Alerts and/or Conservative Operations are in effect during the balance of the year.

Additionally, during the EGCSTF process, PJM and the IMM jointly filed with FERC to allow for generators to submit temporary exceptions after the Day-ahead market closes to address fuel delivery or other restrictions impacting generator operations and availability. This was approved by FERC and incorporated into PJM Manual 11, Revision 129 on 2/22/2024.

2. STANDING COMMITTEE RESULTS

At the June 27, 2024 of the Markets and Reliability Committee, Susan McGill reviewed the proposed solution endorsed by the Electric Gas Coordination Senior Task Force (EGCSTF) and corresponding revisions to Manual 11:

Energy & Ancillary Services Market Operations and Manual 13: Emergency Operations. Following discussion, the proposed solution and associated manual revisions failed in a sector-weighted vote with 2.561 in favor.

John Rohrbach, SMECO, moved and Adrien Ford, Constellation Energy Generation, seconded the EGCSTF proposal without the fuel procurement notification requirements. Following discussion, they withdrew their motion.

Paul Sotkiewicz, Elwood Energy, LLC, moved and David Scarpignato, Calpine Energy Services, L.P., seconded the EGCSTF proposal without the fuel procurement notification requirements. Following discussion, the motion passed by acclamation with no objections or abstentions.
