Endorsements

1. Credit Risk Arising from Bilateral Capacity Transactions

Gwen Kelly reviewed a proposed solution and corresponding Tariff revisions addressing credit risk arising from bilateral capacity transactions. Following discussion, the committee **endorsed** the proposed solution and Tariff associated revisions by acclamation with no objections or abstentions. John Rohrbach, SMECO, noted his intention to request this item be added to the agenda for the October 30, 2024 Members Committee meeting for same-day approval.

2. <u>Capacity Market Enhancements – Data Transparency</u>

Tom Hoatson, LS Power, reviewed a proposed problem statement and issue charge addressing data and analytical transparency relating to the ELCC methodology and underlying assumptions. Following discussion, the committee **approved** the proposed Issue Charge by acclamation with no objections or abstentions.





3. <u>ELCC Capacity Accreditation Methodology</u>

Tom Hoatson, LS Power reviewed a proposed problem statement and issue charge addressing the marginal ELCC capacity accreditation methodology. Following discussion, the committee **approved** the proposed Issue Charge by acclamation with no objections or abstentions.

4. Storage Integration (Phase II): Transmission Asset Utilization in Operations

David Anders reviewed a proposed problem statement and issue charge addressing operations utilization for storage as a transmission asset. Following discussion, Adrien Ford, Constellation, moved and Erik Heinle, Vistra, seconded deferring voting on the issue charge until all education items included in Key Work Activities in the issue charge are completed at the Operating Committee, and that the issue charge not be brought back to the MRC for an additional first read before February, 2025 or vote before March, 2025. The motion to defer was **approved** in a sector-weighted vote with 3.576 in favor.

Scott Baker reviewed the proposed sunset of the CAPSTF. The committee will be asked to approve the CAPSTF sunset at its next meeting.

7. Enhancing Capacity Interconnection Rights (CIR) Transfer Efficiency

A Special MRC meeting was scheduled for for November 14, 2024 to conduct a page turn of the proposed Tariff revisions to support a vote on the proposal at the committee's next regular meeting.
