### Administration

- 1. The Operating Committee (OC) Agenda for this meeting was **approved**.
- 2. The Draft Minutes of the July 10, 2018 OC meeting were approved.
- 3. The Operating Committee Work Plan was reviewed. PJM will continue to solicit input from stakeholders regarding future OC agenda items.
- 4. Ms. Rebecca Carroll, PJM, provided an informational update on the addition of user impact slides to PJM committee presentations.

### Review of Operations

### 5. Review of Operational Events

Mr. Chris Pilong, PJM, reviewed PJM operations for the month of July.

### 5a. July 10 Frequency Excursion Event Review

Mr. Chris Pilong, PJM, provided a review of the July 10 frequency excursion event. The Eastern interconnection experienced a steady decline in frequency resulting from generator trips and a possible bad interchange schedule. PJM is conducting an Apparent Cause Analysis (ACA) as well as working with the NERC Resource Subcommittee, which is tasked with finding a cause of the unexpected frequency excursion. PJM will review the results of the ACA once finalized and communicate individual frequency response data to generators, if possible.

### 5b. Lonesome Pine Area Load Shed Event Review

Mr. Chris Pilong, PJM, provided a review of the July 18 Lonesome Pine area load shed event. The timeline of transmission trippings and actions were reviewed. The Performance Assessment Interval (PAI) resulted in no charges or credits as no generation assets could mitigate the issue within the load pocket.

### 6. Review of Operating Metrics

Ms. Stephanie Monzon, PJM, reviewed the July 2018 PJM operating metrics slides. Metrics included PJM's load forecast error, BAAL performance, transmission / generation outage statistics, and Perfect Dispatch historical performance. Metrics related to the July 10 Frequency event will be reviewed as part of the Apparent Cause Analysis.

### 15. New Markets Gateway Fields to Support Gas Contingency Automation Update

Mr. Brian Fitzpatrick, PJM, provided an update on new fields created in Markets Gateway to support gas contingency automation. PJM is looking for total gas nomination data for units.

### 16. NERC Lessons Learned

There were no lessons learned presented at this month's meeting.





### 17. Reliability Compliance Update

Mr. Preston Walker, PJM, provided an update on NERC, SERC and RFC standards, and other pertinent regulatory and compliance information, and solicited feedback from the members on Reliability Compliance efforts.

### 18. Pricing Interface Update

There were no newly created pricing interfaces.

### **Action Items**

- 1. PJM will review how the PCLLRW data is presented and consider different ways to present the information. Targeting September 2018 to present options for stakeholder feedback.
- PJM will continue coordination in the areas of enhancing the PJM Emergency Procedures Manual (M13) Conservative Operations sections and propose draft manual language at a future OC meeting.
- 3. PJM will provide findings from the Apparent Cause Analysis for the July 10 Frequency Excursion event along with any NERC Resource Subcommittee findings.
- 4. PJM will follow up on status of soak time language updates in the PJM Tariff and Operating Agreement.
