24. Manual 13 and 14D Changes

Mr. Chris Pilong and Ms. Terri Esterly, PJM, reviewed the proposed changes and solicited feedback from stakeholders regarding Non-Retail BTMG manual language for Manual 13: Emergency Operations and Manual 14D: Generator Operational Requirements. **The Operating Committee will be asked to endorse these changes at the next OC meeting.**

Mr. Dave Souder, PJM, notified the OC that a preliminary review of the proposed M-13 and M-14D language changes with the PJM Tariff and Reliability Assurance Agreement (RAA) indicate that no PJM Tariff or RAA changes are required. If the need for PJM Tariff or RAA changes are identified, the proposed changes will be presented at future OC meetings.
