4. Max Emergency Changes for Resource Limitation Reporting
A review of solution packages was performed for the Max Emergency Changes for Resource Limitation Reporting issue as part of the Consensus Based Issue Resolution (CBIR) Lite process.

The committee endorsed Package A with 209 (92%) in favor, 18 (8%) opposed, and 4 abstentions. A second vote showed stakeholders preferred Package A over status quo with 186 (82%) in favor, 40 (18%) opposed, and 5 abstentions.

The committee did not endorse Package B with 19 (9%) in favor, 194 (91%) opposed, and 18 abstentions. A second vote showed stakeholders did not prefer Package B over status quo with 19 (9%) in favor, 194 (91%) opposed, and 18 abstentions

Package A moves to the Market and Reliability Committee (MRC) as the primary motion.

5. Internal NITS Process

Susan McGill, PJM, reviewed the proposed solution package for the Internal Network Integration Transmission Service (NITS) Process issue as part of the CBIR Lite process.

The Operating Committee endorsed the proposed solution with 0 objections and 0 abstentions.

6. Renewable Dispatch

Mike Zhang, PJM, and Joel Luna, Monitoring Analytics, reviewed the joint solution package for the Renewable Dispatch issue as part of the CBIR process.

The Operating Committee endorsed the changes to Manual 10, Manual 12 and Manual 13 with 0 objections and 0 abstentions.
