## Administration (9:00-9:10)

- 1. Mr. Dave Souder, PJM, called the meeting to order and Ms. Molly Mooney, PJM, reviewed the Antitrust, Code of Conduct, media participation, and WebEx guidelines.
- Ms. Molly Mooney reviewed the December 12, 2019 Planning Committee Agenda. There was an additional item posted as an alternate Issue Charge for Agenda Item 5: Critical Infrastructure Stakeholder Oversight.
- 3. Ms. Molly Mooney reviewed the draft minutes posted for the November 14, 2019 meeting and the Planning Committee approved the minutes.

## Endorsements (9:10-10:30)

### 4. Planning Committee Charter

Mr. David Souder, PJM, reviewed the Planning Committee Charter. No changes were made to the Planning Committee Charter. **The Committee endorsed the Planning Committee Charter Revisions with an acclamation vote of 0 objections and 0 abstentions.** 

#### 5. Critical Infrastructure Stakeholder Problem Statement and Issue Charge

Mr. Erik Heinle, Office of the Peoples Counsel for the District of Columbia, and Greg Poulos, CAPS, presented a Problem Statement and Issue Charge related to Critical Infrastructure Stakeholder Oversight. Exelon proposed an alternate Issue Charge. After stakeholder discussion, it was the decision of the Chair to vote on both Issue Charges. Ms. Sharon Segner, LS Power, called a point of order to reverse the decision of the Chair which was seconded by Mr. David Scarpignato, Calpine. The Committee vote did not reverse the decision of the Chair to vote both Issue Charges with a vote of 63 Yes; 104 No; 2 Abstain = FAIL (38%).

Next, the Committee voted on the Issue Charge presented by the Office of the Peoples Counsel for the District of Columbia and then the Issue Charge presented by Exelon.

The Committee passed the Issue Charge presented by the Office of the Peoples Counsel for the District of Columbia with a vote of 84 Yes; 67 No; 4 Abstain = PASS (56%).

The Committee did not pass the Issue Charge presented by Exelon with a vote of 68 Yes; 83 No; 4 Abstain = FAIL (45%).

## 6. Manual 14G Revisions

Mr. Bernie O'Hara, PJM, presented a second read to Manual 14G, Section 2.2 updates regarding projects applying for interconnection under Attachment Y. The Committee endorsed the Manual 14G Revisions with an acclamation vote of 0 objections and 0 abstentions.



 Sunset the DER Ride-Through Task Force Ms. Susan McGill, PJM, reviewed work completed at the DER Ride-Through Task Force. The Committee endorsed sun setting the DER Ride-Through Task Force with an acclamation vote of 0 objections and 0 abstentions.
