The committee will be asked to approve the issue charge and endorse the proposed solution as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 at its next meeting.

5. Working Credit Limit Definitions

Jess Troiano, PJM, reviewed a Problem Statement, Issue Charge and proposed solution to address making aligning the definitions of working credit limits across the Tariff and Operating Agreement. Draft versions of associated Tariff language were posted with meeting materials for informational purposes. The committee will be asked to approve the issue charge and endorse the proposed solution as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 at its next meeting.
