

# Offer Verification – New Process to Submit Exception Request

- If offers greater than \$1000 are rejected in Markets Gateway:
  - Stakeholders have the opportunity to submit an Exception Request
  - Submitted to PJM Connect
    - Excel template and additional supporting documents
- New feature will remove the need to submit the excel template
- Market Sellers will continue providing other supporting documents via PJM Connect, as-is today:
  - Documentation of actual or estimated fuel price
  - Approved Fuel Cost Policy



#### **Fuel Price Exception Enhancement**

- Go-live date: June 2, 2020
- New display in Markets Gateway
  - Enhances the current process
  - Expedites Exception Request submission for Stakeholders
  - Expedites Exception Request processing for PJM
  - Removes Excel Template
  - XML submissions supported
- Additional supporting documents need to be submitted through PJM Connect



- Submit Offers to the Offer Updates Screen in Markets Gateway
- Offers submitted over \$1000 are subject to Markets Gateway automated screen validation
- Offers that fail validation will be capped at \$1000 or highest approved segment
- Stakeholders have the opportunity to submit an Exception Request for offers that fail validation via the new screen, Fuel Price Exception
- Exception Requests that are submitted via the new screen are only valid for offers over \$1000 and fail validation

- Submit supporting data to PJM Connect
  - Any Exception Request without supporting data may be rejected
- PJM will review Fuel Cost Policy in addition to the data submitted to determine if exception should be granted
- If Exception Request is approved, the Max Allowable Offer Price (MAOP) will be updated and any segments at or below MAOP will be considered passed
- No additional action will be required if Exception Request is approved
- Stakeholders will be notified through PJM Connect
