Credit Subcommittee Conference Call July 24, 2018 2:00 p.m. – 3:00 p.m. EPT

Administration

PJM staff reviewed the Anti-Trust Policy, Code of Conduct and Media Participation Policy.

The Subcommittee approved the minutes from the July 13, 2018 CS meeting by acclamation.

An announcement was made encouraging members to communicate ideas to PJM prior to the August 21 CS meeting concerning the FTR mark-to-auction credit requirements so they can be incorporated into the draft matrix which will be discussed at the meeting.

Working Issues

1. Surety Bonds

PJM led a discussion on the draft Surety Bond provisions. Updated draft tariff language was presented for discussion. A poll was initiated after the meeting to gauge support for accepting Surety Bonds, and to gauge support for the draft provisions or alternate provisions. The poll results will be presented at the August 21 CS meeting and will be the basis for discussion of next steps at that meeting.
