1. FTR Mark-to-Auction Credit Requirement

PJM presented the results of the poll which was opened after the September 17, 2018 Credit Subcommittee meeting to gauge the level of support for various option packages presented at that meeting. Based on member feedback, PJM will perform some additional analysis of the Mark-to-Auction proposals for further discussion at the October 23, 2018 CS meeting. A new poll will be held after that meeting in order to gauge interest in the remaining proposal packages. The MIC first read will be moved to the November 7th MIC meeting.
