Administration (2:00 – 2:05)

1. Scott Baker opened the meeting and reviewed the agenda.
2. Hamad Ahmed reviewed the meeting participation guidelines.

Thomas DeVita, PJM, stated that PJM has not made a final decision on requesting an extension on the compliance filing for Order 2222, but said that PJM was leaning more towards a 6 month extension rather than a 3 month extension, as discussed at a prior meeting. Multiple stakeholders in the meeting, mostly TOs, expressed support for a 6 month extension.

Order 2222 – RTO/Distribution Utility/DER Aggregator Operational Coordination (2:05 – 3:55)

3. Stakeholders continued to workshop concepts around an operational framework for DER Aggregation.
 - a. Donnie Bielak, PJM, briefly discussed evolving draft operational coordination framework and highlighting key areas around communication and management model between PJM, aggregator and the utility.
 - b. Sal Salet, PPL utilities, discussed EDC/TO coordination/communication framework for operational dispatch and override. Sal deliberated different challenges surrounding operating a dynamic distribution grid and highlighted automation as a possible solution. Sal also discussed different EDC communication and management models.
 - c. Various representatives from different EDC’s provided their insight and discussed numerous challenges from their perspective highlighting that optionality when it comes to coordination frameworks will be crucial, as all utilities will be in a different phase of grid modernization. EDC’s also discussed reliability and customer benefits and how the grid is evolving.
