



DER and Inverter-based Resources Subcommittee WebEx Only March 3, 2021 9:00 a.m. – 4:00 p.m. ET

Administration (9:00 - 9:15)

- 1. Scott Baker opened the meeting and reviewed the agenda.
- 2. Hamad Ahmed reviewed the meeting participation guidelines. The minutes from the February DIRS meeting and the EDC coordination workshop were approved with 0 objections and 0 abstentions.
- 3. Scott Baker reviewed the DIRS work plan.
 - Scott discussed various timelines regarding Hybrid Resources and DER aggregation/ FERC Order 2222.
- 4. Thomas DeVita discussed PJM's request for compliance extension on FERC Order 2222.
 - Thomas indicated that PJM has requested an extension on the FERC Order 2222 until February 1, 2022. Some stakeholders voiced concerns regarding PJM's plan to put forward a straw proposal during March 31st DIRS for FERC Order 2222, especially given this potential extension of the compliance period. PJM welcomed the feedback and vowed to internally discuss further and report out to stakeholders at the next meeting on 3/15 with their plan for issuing a straw proposal.

Order 2222 – EDC Coordination Workshop (9:15 – 12:15)

- 5. PJM and distribution utility staff discussed aspects of the DER aggregation utility review process and operational coordination framework.
 - a) Pete Langbein, PJM, provided additional thoughts on the DER registration and utility review processes, using use case examples.
 - Pete highlighted proposed DER process emphasizing that the process is a work in progress. Pete discussed key EDC responsibilities for Order 2222, several used cases for registration process, potential aggregation approach, registration review timeline and settlement/compliance.
 - b) Utility presentations First Energy discussed roles and responsibilities for EDCs. Duquesne discussed the 60-day EDC registration process and PPL reviewed examples of real time override scenarios and implications of system constraints.

Order 2222 – Discussion on compliance directives (1:00 – 2:30)

- 6. Stakeholders continued discussion around potential solutions related to the market participation requirements for DER and DER aggregation.
 - a) Madelyn Beban presented PJM staff initial thoughts on metering and telemetry.





- Madelyn put forth PJM's initial thoughts around metering and telemetry requirements and opened
 the floor for stakeholder discussion. Madelyn discussed existing metering requirements and used
 aggregation cases. Stakeholders discussed the benefits and drawbacks to having individual-DER level
 telemetry, as opposed to just aggregated telemetry. Stakeholders requested additional discussion
 and use cases/examples on this topic at a future meeting.
- b) Betty Watson, Modern Energy, sought additional feedback on the proposed solutions put forward by Advanced Energy Management Alliance at the last meeting.
- Betty briefly discussed several topics from last meeting and opened the floor for discussion among stakeholders.

Solar-Battery Hybrid Resources (2:30 – 3:25)

- 7. Stakeholders reviewed progress on the solar-battery hybrid solutions matrix and discussed next steps towards recommending a proposal to the MIC (and OC).
 - Andrew Levitt, PJM, reviewed a new design component "number of resources for MOPR purposes" and discussed verbally the status quo for that item. PJM staff also made changes to package A regarding the solution option for "modeling Energy/Ancillary Services". PJM Stakeholders requested education around the reserve issue and MOPR status quo and requested more time to discuss the solution matrix. A post-meeting version of the matrix will be posted.
 - Ken Foladare, representing Tangibl, reviewed an additional package proposal regarding reserves.
