### Order 2222 – Feedback on PJM Staff Proposal on DER Aggregation from the utilities (3:05 – 4:55)

- 3. PJM presented and stakeholders discussed an updated version of the operational coordination framework between RTO, market participant, and distribution utility.
  - Donnie Bielak, PJM, discussed DERA real-time wholesale Market Operation and Communication Model highlighting key relationships between PJM, Market agent, Dispatch agent, Utility and DERA.
- 4. Sue Glatz, PJM, reviewed its proposal to ensure that DER participating in a DERA are accounted for in the PJM transmission planning model.
  - Sue reviewed several PJM Planning requirements highlighting the status quo for retail connected BTM DERs and concerns with expanded DER participation and continued use of netted generation model. Sue discussed proposed data requirements for Planning for each DER within a DER aggregation and a simplified example of netted and aggregated modeling.
  - Sue reviewed several key points for obtaining Planning modeling data.
