- 1. Scott Baker opened the meeting and reviewed the agenda.
- 2. Hamad Ahmed reviewed the meeting participation guidelines. The minutes from EDC coordination workshop and DIRS from September were approved with 0 objections and 0 abstentions.

Order 2222 - Compliance Proposal Updates (9:15 - 12:15; 1:00 - 2:00)

- 3. PJM staff reviewed modifications to the DER Aggregation Market Participation Model proposal.
 - Danielle Croop, PJM, discussed order 2222 implementation timeline and PJM's guiding principles for design development. Danielle briefly reviewed DERA Jurisdiction and Interconnection topics and Market participation agreements.
 - Tim Burdis, PJM, reviewed several dispute topics and discussed whether they are adjudicated by FERC, by States or both.
 - Ryan Nice, PJM, discussed several topics around Telemetry highlighting specific values to be provided to PJM. Ryan also discussed data frequency and accuracy and reviewed a telemetry example. Ryan also discussed Cyber Security.
 - Danielle discussed outage information needed for DERA CP resources. Danielle also discussed
 Market Participation model, different DER Capacity capability, Energy Market model and comparison,
 bidding parameters available in DERA model and min/max size requirements.
 - Ed Rich III, PJM, discussed topics within Settlements.
 - Pete Langbein, PJM, reviewed DER aggregation registration and review process, DERA's approval next steps and discussed examples for registration data.
- 4. PJM staff reviewed updates to the compliance matrix, as well as alternatives received from stakeholders. One parking lot item was added to the matrix.
