- 1. Scott Baker opened the meeting and reviewed the agenda.
- 2. Hamad Ahmed reviewed the meeting participation guidelines. The minutes from November's DIRS and December EDC coordination workshop were approved with 0 objections and 0 abstentions.

Order 2222 - Compliance Filing - Draft Tariff Review (9:05 - 3:30)

- 3. Thomas DeVita, PJM, will reviewed the draft governing document language associated with PJM's compliance filing.
 - Thomas reviewed several new Operating Agreement definitions such as Aggregated DER, DER Aggregator, DER Aggregation Resource, DER Capacity Aggregation Resource and DER Aggregator Participation Model.
 - Thomas discussed the DER Aggregator Participation Model and the associated information a DER Aggregator would be required to submit. Thomas also discussed the 60 day registration and review process conducted by the EDCs and the ramifications of identified concerns not resolved within 60 day period.
 - Thomas also touched on several key topics within the DER Participation Model such as Pnode, Day-ahead Energy Market and Real-time Energy Market based on bidding parameters, telemetry, bidding parameters, override, participation in the PJM energy, capacity and/or ancillary services Market, Day-ahead Energy Market must-offer requirements, MOPR floor offer price, Market Seller Offer Cap and load reduction resources.
 - Danielle Croop, PJM, reviewed RAA revisions on Planned DER Capacity Aggregation Resource, DER Capacity Aggregation Resource Sell Offer Plan, Existing DER Capacity Aggregation Resource, DER aggregator Officer Certification Form and RAA, Schedule 6.2.
