Market Settlements Subcommittee Conference Call August 18, 2016 1:00 p.m. – 4:00 p.m. EST

Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct and Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the May 20, 2016 MSS meeting.

Tech Change Forum – Overview

Mr. Nick DiSciullo, PJM, provided an overview of the Tech Change Forum, which is a new PJM-led group to coordinate, consolidate and share information about enhancements and planned changes to PJM tools and technology.

Working Issues

2. Capacity Performance – Performance Assessment Hour Charges and Credits

Mr. Ed Rich, PJM, discussed the upcoming billing and report changes related to Performance Assessment Hour Charges and Credits. Details were presented for the Performance Assessment Resource Charge Summary and Performance Assessment Billing Month Summary reports.

PJM will continue to develop additional supporting reports, which will be discussed at the September 22, 2016 MSS meeting.

3. FERC Order 825 – Discussion on Sub-Hourly Settlements

Mr. Ray Fernandez, PJM, discussed the Settlements impacts of FERC Order 825. Ray reminded the Subcommittee of implementation timing, which was originally presented at the August 10, 2016 MIC meeting. He also presented an example of how real-time generator scaling and balancing credits would be handled with sub-hourly settlements and mentioned that no changes are required for generation, load, or demand response metering. Sub-hourly generation data would be accepted, if available, and would be used instead of state estimator or telemetry values.

There were several requests for PJM to provide additional education, including an example that highlights the impacts of sub-hourly settlements on deviations and uplift calculations and how they differ from status quo. There was also a question on how PJM would handle the potential imbalance between generation and load. PJM was also asked to provide a clear delineation of what will need to change from the EDC perspective for load settlement and what the submitter of load may need to change in their system to properly interface with PJM.

Additional examples and education will be presented at the September 22, 2016 MSS meeting.
