Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct and Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the May 22, 2019 MSS meeting.

Members were asked to provide any updates to their NSPL scaling plans. No updates were provided.

Working Issues

1. Non-Retail Behind the Meter Generation

Ms. Terri Esterly, PJM, gave an informational update on the clarification revisions being proposed for Manual 14D: Generator Operational Requirements, Appendix A: Behind the Meter Generation Business Rules. Terri discussed the background and summary of the business rules, and reviewed the upcoming deadlines for all members.

2. Powermeter EHV Net Losses

Mr. Nick DiSciullo, PJM, provided an overview of the upcoming EHV Net Losses Power Meter enhancement, which will give participants an idea of any imbalance prior to the close of the day. The extra EHV row will only be visible to participants who have an effective meter account relationship to the given loss area. The enhancement is planned for a July sandbox release, and an August production release.

3. Order 841 Energy Storage Resources

Mr. Andrew Levitt, PJM, presented proposed revisions to Manual 27: Open Access Transmission Tariff Accounting and Manual 28: Operating Agreement Accounting to provide clarity on the billing impacts of FERC Order 841.
