Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct, Public Meetings/Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the February 19, 2021 MSS meeting.

Working Issues

1. MSRS Refresh Project

Sean Flamm, PJM, gave details on the status of the Production environment release of the refreshed MSRS UI, and presented the forward looking project timeline.

2. FTR MSRS Report Survey Results

Liz Hauske, PJM, reviewed the results of a PJM survey that gauged interest and support of FTR related MSRS report changes that were originally discussed at the February 2021 MSS meeting. Liz detailed that based on survey results, PJM is confident moving forward with report changes. In discussion, PJM noted that the survey was intended to be more informal, and for future surveys of a similar nature, PJM would welcome multiple responses per member organization if applicable. PJM will also send a PDF of the survey as an attachment with the email notification for future surveys.

Miscellaneous Settlements Items

No miscellaneous settlement items were discussed.
