# Administration

Mr. Falin opened the meeting and reviewed the agenda. The meeting minutes from the October 4, 2021 meeting were approved and will be posted as final.

## 2022 Load Model Time Period Analysis

Mr. Gledhill reviewed detailed results of analysis performed by PJM staff regarding the selection of a load model time period for both PJM and the World regions. The analysis focused on the 2026/2027 Delivery Year and followed the procedure approved by the Planning Committee at its July, 2009 meeting.

PJM recommended an 11 year load model based on the years 2000-2010 for use in the 2022 RRS Base Case.

PJM also recommended that the World peak be switched to a different July week so that PJM and World peak on the same month but not on the same week.
