1. Welcome and Announcements
  - A. Monica Burkett reviewed Antitrust Guidelines, Code of Conduct, Public Meetings/Media Participation, and Webex Participant Identification Requirements.

2. Gizella Mali, PJM, provided details on the review of Transmission Owner, Generation Owner and Generation Operator contacts. ## PJM Compliance Activities (9:15-9:35)

3. Manual Updates
  - A. Dean Manno, PJM, provided a manual update on Manual 03. He discussed Section 3.9, Section 3.11 and language added to Attachment A. Dean mentioned that the Manual first read at MRC was on April 27, second read/endorsements at MRC is on May 25 and June 01 is the date of implementation.   - B. Richard Brown, PJM, provided an update on Manual 36: System Restoration. He discussed the v30 revision summary which included the annual review, Attachment D and Attachment G. He mentioned that the first read of the manual was on April 27 at MRC and the second read to be held on May 25 with a June 15 implementation date. 4. Vince Stefanowicz, PJM, reviewed Generating Facility Cold Weather Operating Limits Periodic Data Request.

He indicated the following:

- Action required: Complete 2022 eDART Cold Weather Operating Limit Data Request
- Deadline: 6/30/2022
- Who may be affected: Generation Owners who have not already provided Cold Weather Operating Limit Data.

5. Michael Herman, PJM, provided an update on [CIP-014 CMEP Guide and CB020](#). He discussed the timeline, Applicability List, Models, Technical Analyses under CMEP Guidance. Michael also mentioned that CB-020, including documentation of common risk assessment methodology will be removed from PJM website to avoid conflict with CMEP guidance and TO CIP-014 analysis must align with CMEP practice guide, or may be a potential non-compliance. Lastly he mentioned that PJM will continue to support TO's in review/update of common risk assessment methodology.
